Report from Cllr Calum Miller CDC/OCC

Three OCC consultations at the moment – Local travel, transport and connectivity especially the rural aspect; SENDCO which is a county responsibility, with demand greater than finance; Libraries and Heritage which is a non statutory provision so gets squeezed, libraries have a great role as community hubs.

The possibility of 20MPH zones across the county was discussed, this has been budgeted for by OCC. Parishes would need to opt into this.

Community speedwatch is still in operation, parish would have to invest in equipment, be trained and work with police.

The environmental ambition of the parish was discussed, some one off capital funding related to climate action.

6. Chair's announcements

The Mission Room: currently this is a £1000 annual cost to the Diocese. Proposal for a consultation in the community to see what could happen with it for example an art gallery. PC would like to work with PCC. Possible opportunities for renovation, the PC could raise funds.
